Background and Purpose

The SMDA Co. Board has approved a scheme Charging Model, which sets out how the scheme is funded. The current version of the SMDA Charging Model document is published on the SMDA website: www.smda-scheme.co.uk. That model includes a commitment to publish from time to time a table of fees associated with SMDA testing and assurance.

This document sets out the fees for SMDA testing and assurance. Information such as how the fees are calculated and how they fund the scheme is out of scope of this document, but can rather be found in the accompanying Charging Model document.

Definitions

The key definitions used in SMDA scheme documents are provided in the SMDA Glossary Document. Additional definitions for the purposes of this document are set out below:

SMDA Assurance: Those SMDA testing and assurance activities mandated by the SMDA scheme in

order for a device to be assured and thereafter added to the SMDA Device Assurance

Register.

Re-testing: The re-running of some or all of the testing and assurance process for a device

following a failure in SMDA Assurance testing and assurance activities.

Partial testing: Those SMDA testing and assurance activities following a Device exemption or

Baseline exemption process as defined within the SMDA scheme documents.
